

# IMIDASECTANTS



## GEL BAIT INSECTICIDE AGAINST ANTS

**Formulation:** Ready-to-use gel  
**Active substance:** Imidacloprid  
**Chemical family:** Nitroguanidines (Neonicotinoids)  
**Concentration:** 0.01% w/w  
**Appearance:** Colourless liquid (gel) with characteristic odor  
**Target insects:**  
Pharaoh ants (*Monomorium pharaonis*), Argentine ants, (*Linepithema humile*) and Black ants (*Lasius niger*).

### Mode of action:

The active ingredient imidacloprid acts by binding to the insects neurons. This binding causes a disturbance in the transmission of nerve impulses which is lethal to the target insect. Ants are attracted by nutritional ingredients in the bait. They spread the gel by moving and contaminate their peers, causing poisoning (by contact and ingestion) and death of all individuals within ten days, regardless of their stage of development (larvae, juveniles, adults).

### Use instructions:

**Indoors,** place the gel in drops or thin lines near ant trails, points of input to locals and their nests. Apply where ants are present. In areas where presence of ants is suspected or detected sporadically, it is recommended to use the gel in a bait box.  
**Outdoors,** place the gel in drops or thin lines in the ant nests or trails. Apply where ants are present. When their presence or activity is suspected, it is recommended to place the gel in a bait box inside to protect from rain or extreme environmental conditions. Whenever possible, it is desirable to remove other food sources nearby so that they do not interfere with consumption of gel.

#### Indoor use

TARGET SPECIES	APPLICATION RATE
Pharaoh's ants and ghost ants	Apply spots of product on or alongside trails at 1-2drops product per square metre
Black ants	Apply in cracks and crevices on or alongside ant trails at 1 drop product per linear metre up to a maximum of 2 grammes total

#### Outdoor Use

APPLICATION RATE
Apply 1 drop of product directly into the tunnel entrance or application paths

### Intended uses:

Insecticide for professional use against Pharaoh ants and other ant species.

For use indoors in domestic premises, food handling and storage areas (excluding use on grain or in grain stores) and public buildings such as cinemas, hospital wards, hotels, municipal buildings, churches and halls

For use outdoors, on terraces, pavements, patios, entrance areas to sheds, garages. For use on lawns only when contained in a bait station.

Not for use on soil or flower beds.

### Remarks:

Do not apply the gel in areas where regular cleaning can move the bait to the surfaces that come into contact with foodstuffs.

Do not apply the gel in areas regularly cleaned with water as the washing can remove the gel deposit. Do not apply the gel in areas recently sprayed with insecticide. Do not spray insecticide on the gel. The application of gel on textile may cause discoloration.

### Storage:

Keep the product in its original packaging out of the reach of children and pets.

Keep away from food, drink and animal feedingsuffs.

Under normal storage conditions, IMIDASECT ANTS can be stored for 2 years.

### Packaging:

The packaging should be disposed as hazardous waste under the sole responsibility of the holder of that waste.

### Precautions:

After using IMIDASECT ANTS and before eating, wash your hands with soap and water. Do not apply the gel to surfaces where food is stored, prepared or consumed. Protect food, cooking utensils and cutlery from contamination. Do not apply the gel in places accessible to children and pets.

When using do not eat, drink or smoke.

Avoid excessive contamination of cloths.

DO NOT USE where food, feed or water could become contaminated. PREVENT ACCESS TO BAITS by children and animals.

This material and its containers must be disposed of in a safe way.

Hazardous TO BEES

USE ONLY in positions inaccessible to children and animals.

WASH HANDS AND EXPOSED SKIN before meals and after use.

### First aid:
